**RE: Town of Melbourne Beach – City Hall & Fire Dept Showers**

## **Background Information:**

At the Regular Council Meeting on August 20 2025, information was shared regarding the leaking showers on the second floor of Town Hall. These showers are part of the Fire Departments protocol for decontamination following emergency response. A contractor was hired to repair the leaks which resulted in complete gutting of the three shower stalls (two men/one woman). Three quotes have been obtained providing similar scope and price for the replacement of the shower stalls.

### **Attachment:**

**EXHIBIT A** provides a copy of the three proposals listed as follows:

1. Sun Plumbing	\$15,781.26
2. Expedition Roofing (CGC1533344)	\$14,989.00
3. LH Tanner Construction Corp (CGC1511228)	\$25,527.00

**Sun Plumbing:** Includes prefabricated showers, all plumbing and new fixtures; excluding grab bar and build out of walls to fit the prefabricated showers. Sun Plumbing does not perform general contracting work.

**Expedition Roofing:** Includes all general contracting and plumbing work to accommodate new prefabricated showers including grab bars and new fixtures, since they are a general contractor with a plumbing license.

**LH Tanner:** Includes all general contracting and plumbing work, as well as fixtures including the grab bars, but proposes utilizing tile in lieu of prefabricated. Additional costs have been allocated to painting touch up and ceiling tile replacement. General contractors and licensed plumbers.

## **Recommendation:**

TM recommends acceptance of one of the general contractor company proposals for completion of the City Hall & Fire Dept Showers. Commission determination of tile or prefabricated showers should be based on costs, maintenance and lifespan of materials.

Prefabricated materials are lower costs and maintenance yet have a lifespan of 10 – 20 years.

Tile has a higher costs, slightly higher costs of maintenance, but has a lifespan of over 40 years.

Funding: General Government Services Expenses #19-510.49.98, Contingency.



**Additional Work Timing Notes.**

Core drilling will / can be performed during evening hours after City Hall closes to minimize noise disruption. This core drilling is necessary because the existing upstairs drains do not align with the new shower trays being installed; new holes need to be drilled to allow for proper connection and alignment with the existing plumbing located in the ceiling of the floor below.

Plumbing work for the shower valves will / can also be completed after office hours to avoid water supply interruption.
