No Dogs On the Beach

Please be advised the Town of Melbourne Beach follows the Brevard County Ordinance regarding dogs and other animals on the beach:

Sec. 14-60. - Public parks and beaches.

- (a) No animal shall be permitted or allowed into or on any public park or beach; provided, however, that an area in a public parks or beach may be designated for animals by resolution of the board, or by the governing body of any applicable municipality. In that event, the area provided for animals must be properly identified and posted by the county or the appropriate municipality.
- **(b)** It is a violation of this article for the owner of an animal to permit or allow the animal into, or on, any public park

or beach not designated for animals and not properly identified and posted. However, a disabled person, as defined under the Americans With Disabilities Act, shall have the right to be accompanied into or on any public park or beach by a service animal without violating this section.





Local Emergency Alerts





Town of Melbourne Beach residents are encouraged to sign up for our local emergency alert systems. Click the links below to be directed to the registration process for each alert system.

<u>Nixle Emergency Alert System</u> is used by the Melbourne Beach Police Department to send out email notices to the public.

<u>CodeRED Emergency Alert System</u> is used by the City of Melbourne.* It is put into action when needed to send emergency messages by phone, text, and email. These messages are sent for large-scale precautionary boil water notices that can be caused by major water line breaks.

*The City of Melbourne provides water and utilities to the residents of the Town of Melbourne Beach.

<u>AlertBrevard</u> is used by Brevard County Emergency Management, Utilities, and Fire Rescue to notify businesses and residents for public safety purposes such as hazardous materials incidents, wildfires threatening homes, boil water notices, and other emergency situations. The calls will provide specific instructions for people to follow in order to keep themselves and others safe.

Fiscal Year 2024 Audit Results

On April 30th, Zach Chalifour from James Moore & Co. presented the results of our annual audit in a Town Commission Workshop. We're pleased to report that the Town had a perfect audit for 2024 with no findings! This is an incredible achievement for Finance Manager Kerr and her department. Congratulations! Community Safety Initiative Recap

We recently wrapped up a successful Helmet and Low-Speed Vehicle Safety Initiative, including a focused Enforcement Day on Tuesday, April 29th. Here's a quick look at what we accomplished:

- Officers engaged with students and families near the school to promote helmet and traffic safety
- 9 informational pamphlets were handed out to children not wearing helmets
 - o 6 of those children did not have a helmet and were each provided one
- Over 50 children were observed properly wearing helmets
- All children and adults observed in low-speed vehicles were wearing seatbelts
- Officers stopped:
 - 4 juveniles on bicycles to provide educational pamphlets
 - 3 adults on bicycles who ran stop signs; they received verbal warnings
- On Enforcement Day (April 29th), officers:
 - Reminded families about Florida's helmet law (required for anyone under 16)
 - Ensured cyclists were obeying traffic rules
 - Checked that low-speed vehicles followed regulations, including:
 - No driving on sidewalks
 - Proper town sticker or license tag displayed
 - Seatbelts worn correctly

Low Speed Vehicles & E-Bikes - What are the Rules?

Low Speed Vehicles (LSVs)

- Only people who have an actual driver's license can drive a LSV
- Everyone in the front seat of the LSV must wear a seatbelt
- Everyone under the age of 18 must wear a seatbelt
- No child can sit on a lap in a LSV
- Children who are mandated to be in a car seat in a car must be in a car seat in a LSV
- LSVs must be registered with the Town or the State of Florida
- LSVs cannot drive on the sidewalk or grass and must stay on the road in the proper lane
- Violations of the above can range from traffic citations to arrest depending on the situation

E-Bikes

- Class 1, 2, and 3 E-Bikes are entirely legal and allowed anywhere regular bikes are permitted
- Class 4 E-Bikes must be registered with a licensed operator, and are considered a motor vehicle
- E-Bikes must have a label that includes the classification number, top-assisted speed, and motor wattage
- It is illegal to tamper with or modify the E-Bike in a way that changes its speed capabilities or classification without updating the label
- If rider is under 16, they must wear a helmet like a regular bicycle
- E-Bikes must follow all traffic rules like stopping at stop signs and riding with the flow of traffic

Volunteer Spotlight - Lauren Hardman

Lauren's first paddling practice for dragon boat racing took place on August 12, 2017. After 1½ years on a team, she was asked to step into a coaching role. She took her team to Nationals, and they were on track to attend Worlds before it was canceled due to COVID. In 2022 her team once again made it to Nationals, then attended Worlds in Sarasota. From there, Lauren joined a more competitive team near The Villages called The HEAT. As a member of The HEAT, Lauren has attended Club Crew Nationals and Club Crew Worlds in Ravenna, Italy (CCWC). She attended her first Team USA tryouts in November of 2024, and was invited to the team in March of this year. Worlds 2025 will start on July 14 in Brandenburg, Germany, and the Olympic Committee will be watching to explore the possibility of adding dragon boating to the Olympics. Lauren attributes her success to the support of her family, her coach Tek Li, and her weight trainer and nutritionist Lauren Brandon. Lauren joined the MBVFD in 2003, inspired to make a difference after the events of 9/11. Initially, she wanted to focus on the Marine Rescue side of the department, which required her to start as a firefighter. With a three-year-old and one-year-old at home and a husband



at sea, Lauren began training. Eventually, Chief Seth Stark pushed her towards the Driver/Engineer path. With that under her belt, she started working towards instructor certification. Thanks to her BA in Secondary Education & Mathematics,

Through it all, she has retained a passion for Marine Rescue. The MBVFD is so proud of her hard work and will be cheering her on for Worlds 2025!

5 Steps for Hurricane Preparedness



Step 1 of hurricane season preparedness is knowing your risk.

Things to consider when assessing your risk:

- Do you live in a mobile or manufactured home?
- Do you live in an evacuation area?
- Do you live in a flood-prone area?
- Are you water or electricity dependent, or do you have special needs?

Always have an evacuation plan for a tropical storm or hurricane. If a storm is approaching and you feel unsafe in your residence, find a location where you feel safe for the duration of the storm.

Step 2 of preparedness is build a kit.

A disaster supply kit is a collection of essential items you may need in the event of tropical storm or hurricane. Assemble your kit, and review it annually. If you evacuate, take your kit with you.

Step 3 of preparedness is having a plan. It is important that your family has a plan if a tropical storm or hurricane is in the forecast. Consider the following questions when making a plan:

- What factors will make me evacuate?
- Where will I go if I need to leave?
- When will I leave to ensure my safety?
- Who is coming with me if I evacuate?
- How far will I travel if I leave?

Step 4 of preparedness is stay informed. Information is critical before, during, and after a tropical storm or hurricane.

Get vital emergency information multiple ways:

- Follow Brevard Co. Emergency Management on Facebook, Twitter & Nextdoor
- Text BREVARDEOC to 888777 for countywide text notifications
- Ensure Wireless Emergency Alerts (WEA) on your cell phone are turned on
- Use a weather radio tuned to 162.550
- Sign up for AlertBrevard location-based notifications: https://www.brevardfl.gov/ EmergencyManagement/AlertSignup





Step 5 of preparedness is get involved. There are many ways to get involved:

- Talk to your neighbors so that they know their risks and encourage them to be prepared.
- Before donating any goods, wait for instructions from local officials or check with a specific organization.
- Make a financial contribution to a volunteer agency involved in disaster relief.
- Volunteer with existing disaster support organizations such as United Way, 2-1-1 Brevard, the Salvation Army, and Brevard Voluntary Organizations Active in Disaster (VOAD).

Charter Review Committee

The Charter Review Committee held their final meeting on May 5, 2025 which was then immediately followed by a joint workshop with the Town Commission. At the workshop, they advised the Commission on the changes to the Town Charter that they suggest should go to referendum.

Environmental Advisory Board

The EAB continues to work on the sea turtle conservancy lighting ordinance and landscaping/tree ordinance. They are working on details for an e-waste roundup and a hazardous waste roundup. The Board recently presented an impervious surface comparison for FL beachside communities to the Commission. They are also looking into ways to educate the community on invasive lizards.

Sea Turtle Nesting Season

Atlantic sea turtle nesting season officially began on March 1st. From now through November, female sea turtles will return to our beaches to lay their eggs. Nesting and hatching is a very difficult process for sea turtles. What can you do to help?

- Avoid lights on the beach at night (flashlights, cell phones, other sources of artificial light)
- NEVER disturb a nest or turtle
- If you dig a hole on the beach, fill it and smooth the sand before leaving
- When boating, obey speed signs and don't anchor in seagrass
- Pick up litter to prevent turtles from mistaking trash for food
- If you see a turtle, hatchling, or nest you think is in distress, contact the Sea Turtle Preservation Society Emergency Voicemail at (321) 206-0646
