In this busy election year, it is important for Brevard residents to Be Election Ready. For anyone wanting to register to vote, Florida offers online voter registration, which can be found on VoteBrevard.gov. To complete your registration online, you will need a Florida driver license or Florida identification card. If it is more convenient, paper voter registration applications are available at any of the 4 Supervisor of Elections Offices located in Titusville, Viera, Melbourne, or Palm Bay.

For those who are already registered, you can verify your voter registration is up to date on VoteBrevard. gov by clicking the "Registration Status" tab at the top of the page. This will also allow you to view your precinct and polling location, check your party registration, check the status of your mail ballot, or view a sample ballot. To find important dates and deadlines for the remaining 2024 elections, click on the "Current Elections" tab on VoteBrevard.gov. It's important to remember the last day to register to vote for an election or change your political party affiliation is 29 days before each election.



Florida is a closed primary state and only voters registered with a political party can vote in that party's Primary Election. All voters can vote in nonpartisan races such as judicial, school board, municipal, and referenda.

Voters have the option to choose one of 3 methods to cast their vote in Florida. The first option is vote-by-mail. As of Dec. 31, 2022, all mail ballot requests expired, and voters are required to make a new request to receive mail ballots. To request a mail ballot, visit VoteBrevard.gov and click on the "Request Mail Ballot" tab at the top of the page, visit one of the 4 administrative offices, or call the mail ballot department at 321-290-VOTE (8683). New mail ballot requests are good for all elections through Dec. 31, 2024.

It is particularly important for those who vote-by-mail to have a current signature on file with our office because all signatures on returned voted mail ballots are compared with the signature in a voter's record. To update your signature, fill out a voter registration application and submit the original to one of the 4 administrative offices in person or by mail.

The second method of voting offered is Early Voting. Brevard has 10 convenient Early Voting locations throughout the County. Something not everyone may be aware of is that you can go to any of the 10 Early Voting locations to vote and we can provide your precinct specific ballot. Locations and hours for the 10 Early Voting sites that will be available for the Primary and General Elections can be found on VoteBrevard.gov by clicking the "Early Voting" tab at the top of the page.

The final method available to cast a ballot in Florida is at the polls on Election Day. If you're waiting to vote until Election Day, remember you must vote at your precinct specific polling location. Since Election Day is a voter's last chance to vote, and life can be unpredictable, we encourage voters to head to the polls early in the day to ensure they do not miss their chance to vote.

The Brevard County Supervisor of Elections Office takes election integrity seriously and has a dedicated page on VoteBrevard.gov which details the efforts taken to ensure the electoral process is secure and transparent. This office is the trusted source for election related information and voters are encouraged to verify information they've seen or heard by visiting VoteBrevard.gov, calling 321-290-VOTE (8683), or following my verified Facebook and X accounts.

March 20, 2024 – Regular Town Commission Meeting

- Fire Department presentations including a proclamation commemorating 33 years of dedicated volunteer service to the Town of Melbourne Beach provided by Retired Fire Lieutenant Stephen Stewart, the swearing in of two new State Certified Volunteer Firefighters Michael Bellucco and George Walters, and the acceptance of a \$5,500.00 donation from the MBVFA
- Presentation of the Fiscal Year 2023 Financial Audit by James Moore
- Approved extending the Waste Pro contract
- Approved the Beach Ambassador program
- Tabled the consideration on ordinance language changes related to sheds
- Approved the language for the second kitchen repeal ordinance
- Approved obtaining quotes for a traffic study of all major roadways
- Failed for a lack of motion consideration of upcoming Regular Town Commission Meeting dates
- Approved the salary for Police Chief Tim Zander at \$105,000.00
- Approved Resolution 2024-02 Budget Amendment
- Approved authorizing the Town Attorney to review and present a draft ordinance to prohibit sleeping/camping
- Approved sending the gaga ball pit idea to the Parks Board to come up with a plan on structure type and location
